City Administrator Report 11/18/2024

Below is the list of significant items that the City Administrator and City Hall are actively working on.

Lead Line Inventory and Reporting: On October 7th, the EPA approved updated Lead and Copper rules for municipal water supplies. The new rules that will be implemented will lower the acceptable level of lead that can be present in a water system from the current 15 parts per billion or .0150 MG/L to 10 parts per billion or .0100 MG/L. The new rules will require systems with more than 10% of the tested locations above the new threshold to enact a service line replacement program. Compliance with this standard will be required within ten (10) years.

The EPA rule will likely face legal challenges. The City is awaiting more information before taking further action. A rough analysis of the cost of replacing all service lines in Centerville would be between \$7 million and \$12 million in construction costs.

The City has submitted its lead line inventory to the Iowa DNR. The federal government has implemented the BIL program, which requires this inventory to be completed by October this year. The next phase of the reporting is sending letters to residents who have lead pipes or pipes of unknown status. The initial round of letters was sent the week of October 28th. A second round of letters will be sent to the addresses that we received bounce back on in the coming weeks.

STAR Contractor Program: City Hall, in partnership with PACT, is in the process of rolling out the STAR Contractor Program. The initial portion of work will be to collect the names and business information for contractors in Appanoose County from all trades.

As part of the list, the contractors will be invited to be STAR contractors which will be on a preferred contractor list for the area. The STAR program will verify that the contractor is registered with the State of Iowa, that they have the proper insurance and bonding, and that they are responsive to customer issues. The STAR contractors will also be on the email distribution list that will receive regular updates on properties that the City acquires.

Administrator Annual Review: The annual review is scheduled for the December 2nd City Council meeting. Council members can contact Kayla Moorman if they have any questions.

Square H Frames—Alliant Energy: Significant work has been completed to remove the structures. Only a few structures remain overhead, and many footings remain to be removed. The administrator spoke with Liberty Communications/Natel on 08/22 regarding removing the

remaining sections of H Frame infrastructure. Liberty is actively working on removing the service and working with a third party to get the switchover of the fiber without disrupting businesses on the Square.

Policy and Pints: The City Administrator is hosting a public meeting series called Policy and Pints. This series provides an informal platform for the public to interact with their City government. The mayor, up to two City Council members, and possibly a department head will join the administrator at each meeting. We highly value your participation and encourage you to join one of these sessions on November 25 at 5:30 p.m. at the Pit Pony Pub.

Sidewalk Court Case: The Iowa Supreme Court reached a ruling on the issue of sidewalk maintenance. The Court has determined that cities can be held liable for accidents that occur on sidewalks due to lack of maintenance or other hazards. Cities can still require maintenance by property owners, but the City would have the ultimate liability in case of an accident. The City Administrator is working on a sidewalk replacement report/proposal for the City to ensure that we are taking the appropriate action to ensure sidewalks are maintained.

Homelessness: The Administrator has been working with the Central Iowa Shelters and Services (CISS) from Des Moines and local volunteers on multiple projects to address homelessness in Centerville. One project is establishing a Housing Command Center to consolidate access into the service pipeline. The City has contacted Casey's about the possible donation of their site at 10th and Maple.

A second project will assist in accessing grant funding for constructing multiple housing units on infill lots. This funding would utilize local contractors to build homes at the workforce housing level.

Recodification: Cities in Iowa are required to recodify their City Codes. The City is working with Simmering-Cory/Iowa Codification to complete this process. The administrator is drafting a survey to go out via Facebook to seek additional input from the community regarding policy updates that the community would like to see.

Appanoose AM: Appanoose AM has invited the City for a monthly session on their morning show. This platform offers a unique opportunity for a City Employee and an elected official to share their insights and engage with the public. The scheduled dates are January 22, February 12, March 11 (Kruzic), April 8, May 13, June 10, July 8, August 12, September 9, October 14, November 12, and December 9. If you're interested in participating, please inform the City Administrator of your availability and preferred topics.

City Council/Board of Supervisors work session on EMS: At their September 5, 2023, meeting, the Appanoose County Board of Supervisors declared EMS Essential. This was the first step in a possible citizen vote for a countywide EMS levy.

The City Administrator met with the Board of Supervisors at their November 6, 2023, meeting to discuss a path forward on funding options. The Supervisors have established an EMS advisory board with members from each first responder group. This committee has been tasked with providing long-term EMS funding options, possibly including a ballot question at the November 2024 general election. The election can be a regular City, Special, or general election.

The County held its first EMS committee meeting on February 15th and has held multiple meetings with the EMS committees. The EMS committee formally recommended that the Board of Supervisors put a 1% income surtax and a \$.75/\$1000 EMS tax on the November ballot. The Board of Supervisors passed a resolution at their July 1, 2024, meeting to place the EMS question on the Tuesday, November 5th, 2024, general election.

The City Administrator sent a draft of a 28E agreement to provide EMS services to Appanoose County, a copy of which is included with this report. This will be on the future agenda for the county and the city, but as of this report, no date has been set.

After two years of work, the voters of Appanoose County overwhelmingly approved the EMS Levy. The City will continue the work with the Appanoose County Board of Supervisors to finalize the budget components of the new levy.

Pool Painting: No update since last meeting.

Water Quality Improvement Project: The City was awarded a \$890,000 grant from the Iowa DNR for a Water Quality Improvement Project in our drainage districts. The Administrator met with the USDA and DNR to get base approval for the High School parking project. The City will also likely get an additional \$100,000 from the USDA for the project.

Housing Abandonments/Demolitions for 2024: 908 S. 16th (demolished), 904 S. 16th (demolished), 509 E. Clark (demolished, conveyed), 827 S. 16th (Conveyed), 217 E. State (demolished), 114 N. 15th (City-owned, pending clearing), 520 E. Elm (demolished, conveyed), 519 W. Elm (Demolished), 801 S. Main (conveyed), 202 W. Wall (city-owned, pending demolition); 1337 Haynes (city-owned, pending demolition), 1418 S. 22nd (Demolished)

Demolition Grant Program: Six properties have been approved for the demolition grant: 714 S. 17th, 706 W. Maple, 505 N. Park, 1115 S. 18th, 109 N. 18th, and 115 N. 18th. Based on the

average cost of City demolition, this represents a cost avoidance to the City of approximately \$50,400 to date.

Airport Repairs: The airport lighting project is complete and closed out. The pavement rehabilitation project is now complete and pending closeout with the FAA. The airport's Solar Array work is under contract and pending construction. The Solar project will be a 28.8KW array and is 90% funded by the FAA.

Agenda Requests not included on Agenda: City Hall receives more agenda requests than are presented at each City Council Meeting. The City Administrator evaluates each to ensure that the business to be discussed is appropriate for the City Council to decide.

Dust Control on South Main at Green Street – Patti Fadiga. This report includes photos and material about Dust Control requirements by the DNR. The City has contracted with a vendor who has applied Dust Control for this season. The City is developing a paving project to address the area after the contracted Chip Seal company failed work in Centerville this year.



Act When both houses of congress approve a bill and the president approves it, the new law is called an act.

Ambient air The air to which the general public has access.

Area source Refers to a series of small sources that together can affect air quality in a region, such as a community of homes using wood stoves for heating.

Attainment An area that meets or is better than the primary National Ambient Air Quality Standard.

Biogenic sources Air pollution sources that are natural, such as trees and vegetation.

CAA Clean Air Act.

Code of Federal Regulations (CFR) The official record of all regulations created by the federal government. It is divided into 50 volumes, called titles, each of which focuses on a particular area.

DERA Diesel Emissions Reduction Act

Federal Register Regulation proposals are listed in the Federal Register so that members of the public can consider it and send their comments to the EPA. Will sensitive populations be impacted?

The proximity of certain facilities to sensitive populations is of special concern. Sensitive populations include children, the elderly, pregnant women and those with existing health problems (such as asthma and emphysema) that make them especially vulnerable to the effects of air pollution. The costs of increased hospitalizations, medication use, and lost work and school days are burdens we all share when the air is not healthy for sensitive populations.

For example, the location of schools, day care centers, playgrounds, senior living facilities, nursing homes and medical facilities should have an appropriate separation from industrial facilities, freeways, rail yards, chrome platers, dry cleaners using perchloroethylene, and other emitters of air toxics and criteria pollutants.

The chart on page 6, "Recommended Siting Distances for Source Categories from the Vicinity of Sensitive Populations," is based on recommendations from the California Environmental Protection Agency and the California Air Resources Board. Those entities carefully reviewed data available for each air pollution source category and epidemiological studies of health risks by relative exposure for non-cancer and cancer impacts and established these recommended minimum separation distances for siting new land uses.

The information is not regulatory or binding. Keep in mind that wind, meteorology, and topography

could possibly increase or decrease risks depending on local conditions. These recommendations are offered to fill a gap where information about existing facilities may not be readily available.

Land use planners should work with the local emergency planning committees (LEPCs) to develop maps that locate facilities with chemical inventories to make sure facilities that serve sensitive populations and residential areas will not be at risk by accidental releases.

What is immediately downwind from the proposed project?

Wind variables are speed and direction. Wind speed determines the amount of initial pollution dilution experienced and how high the pollution may rise. Wind direction determines the transport direction of emitted pollution. Terrain features and urban structures also influence air flow.

Sensitive populations that are in a prevailing wind direction from a proposed project are considered to be downwind from the proposed project. This makes the sensitive populations more likely to be impacted by the proposed project. More information on weather and terrain effects on pollution movement is in Appendix C.

Is the project designed to reduce air pollution exposure?

A number of design options can impact air quality, depending on the site concerns. Natural barriers of shrubs and trees or constructed barriers could

APPENDIX B

Air Pollutants and Health Threats

An air pollutant is defined as a substance in the air that, in high enough concentrations, produces a detrimental environmental effect. A pollutant can affect the health of humans, plants and animals, and nonliving materials such as paints, metals and fabrics.

Air pollutants can either be particles or gases. A primary pollutant is one that is emitted into the atmosphere directly from its source and retains the same chemical form, such as solid waste ash. A secondary pollutant is one that is formed by atmospheric reactions of precursor or primary emissions. Secondary pollutants undergo a chemical change once they reach the atmosphere. Ozone is an example of a secondary pollutant.

Secondary pollutants are more problematic to control because precursor compounds and their sources need to be identified to understand the specific chemical reactions that result in the formation of the secondary pollutant.

Criteria Pollutants

Criteria pollutants are those identified as being both common and detrimental to human welfare and are found over all the United States. These are ozone (O_3) , carbon monoxide (CO), nitrogen oxides (NOx), sulfur oxides (SOx), particulate matter (PM2.5 and PM10) and lead (Pb).

Ozone is formed during a photochemical reaction, meaning several common airborne pollutants react with sunlight to form another pollutant called ozone. Ideal conditions for ozone formation are warm, windless days with bright sunlight found during the summer and early fall.

During these conditions, volatile organic compounds (VOCs) react with nitrogen oxides, also called "ozone precursors," to form ozone. Volatile organic fumes come from evaporation of gasoline, paint, solvents, consumer products, varnishes and industry chemicals. Nitrogen oxides come from high-temperature combustion found in exhaust from auto and truck engines, boilers, utilities and other sources. The concentration of these precursor gases, the volume of air to dilute and mix, the temperature and intensity of ultraviolet light affect this process.

Both urban and rural areas of the state are subject to elevated ozone levels as winds carry emissions hundreds of miles away from their original sources.

Ozone has the same chemical structure whether it occurs miles above the earth or at ground level and can be "good" or "bad," depending on its location in the atmosphere. Six miles up is the second layer of atmosphere called the stratosphere. The stratosphere, or "good" ozone layer, extends upward from about 6 to 30 miles and it protects life on Earth from the sun's harmful ultraviolet (UV) rays. Groundlevel or "bad" ozone is an air pollutant that is harmful to breathe and it damages crops, trees and other vegetation.

Carbon monoxide is an odorless, invisible gas that reduces the ability of blood to carry vital oxygen. Persons with heart conditions are at special risk when exposed to elevated levels. Visual impairment, reduced coordination and mental confusion are all associated with exposure. High exposure can poison, and even cause death, in healthy persons.

Carbon monoxide is especially dangerous inside homes and buildings. In heavily traveled and congested urban areas, carbon monoxide levels can be elevated. Extended exercise such as running and cycling in these areas may not be advisable.

Carbon monoxide is emitted from automobiles and from oxygen-starved fires, such as a smoldering pile of leaves or dampened-down fireplaces.

Widespread leaf burning and storm-related disaster burning of large quantities of brush and downed trees can impact local carbon monoxide levels. This can be magnified during thermal inversions (warm air trapping cool air beneath, causing carbon monoxide molecules to concentrate rather than disperse).

Nitrogen oxides are emitted from high temperature combustion sources such as autos, trucks, aircraft and from boilers used to provide heat, steam or electricity.

Since air is made up of almost 80 percent nitrogen, when high temperature burning occurs, some of the nitrogen in the air is burned to release nitric oxide

reddish-brown haze over urban areas or areas near large emitters.

Airborne nitrates reduce visibility, contribute to acid rain, play a major role in the formation of ozone smog or react with other chemicals to form particulate matter. These particles can fall to earth in rain or snow to increase nitrogen levels in soils and water bodies. Nitrates deposited into water contribute to algae blooms that can cause depleted oxygen.

Sulfur dioxide is the leading contributor to acid precipitation that can harm water bodies, fish and amphibian populations, and forests across the Upper Midwest, Northeast and Canada. Acid rain also impacts portions of the Rocky Mountains and other areas.

Sulfuric gases and particles can slowly degrade building materials such as brick and mortar, pipes and metal surfaces, paints, stone and monuments. Airborne sulfates, along with particulate and nitrogen oxides, also contribute to visibility loss or haze. In lowa, visibility loss due to sulfates and other airborne particles may be approximately one-third natural visibility on average days and less on the worst days.

When sulfur-containing fuels such as gasoline, coal and fuel oil are burned, the sulfur is released. Citizens can help reduce emissions by conserving electricity, properly maintaining vehicles, driving less and by consolidating errands.

Particulate matter is airborne mists, fumes, soot, aerosols, ash or dusts. Smoke is the most obvious form of particulate matter. Smoke is visible when dense concentrations of microscopic particulates are present. Airborne particles invisible to the naked eye can remain suspended in the air for weeks. Particulate matter can also form when airborne chemicals react to change from gases into liquid aerosols or solids. Some particles carry attached molecules of toxic substances.

throat irritation, premature death and reduced visibility from haze. Very fine particulates can travel hundreds, even thousands of miles in the wind before settling out or falling to earth in rain, snow or fog.

Two particulate sizes, PM10 and PM2.5, are regulated pollutants for health and environmental concerns. PM10 means each microscopic particle is 10 microns or smaller in diameter and these particles are created in the cutting, grinding and crushing of materials. PM2.5 includes particles 2.5 microns or smaller in diameter. They are so small they bypass respiratory defenses to penetrate the deepest lung passages and can even become absorbed into the bloodstream. In the bloodstream, they contribute to plaque buildup in arteries and increase the risk for and effects of heart disease, and enter the organs and the nervous system, including the brain. Sources of PM2.5 are industrial and residential combustion, vehicle exhaust and wood burning.

Lead is a metal found naturally in the environment as well as in manufactured products. Since lead has been phased out as a component of gasoline, the major source of lead emissions is metals process- ing. The highest levels of lead in air are generally found near lead smelters. Other stationary sources are waste incinerators, utilities and lead-acid battery manufacturers.

APPENDIX D

Iowa Fugitive Dust Regulation 567 Iowa Administrative Code 23.3(2)"c"

(1) Attainment and unclassified areas. A person shall take reasonable precautions to prevent

particulate matter from becoming airborne in quantities sufficient to cause a nuisance as defined in lowa Code section 657.1 when the person allows, causes or permits any materials to be handled, transported or stored or a building, its appurtenances or a construction haul road to be used, constructed, altered, repaired ordemolished, with the exception of farming operations or

dust generated by ordinary travel on unpaved roads. Ordinary travel includes routine traffic and road maintenance activities such as scarifying, compacting, transporting road maintenance surfacing material, and scraping of the unpaved public road surface. All persons, with the above exceptions, shall take reasonable precautions

to prevent the discharge of visible emissions of fugitive dusts beyond the lot line of the property on which the emissions originate. The public highway authority shall be responsible for taking corrective action in those cases where said authority has received complaints of or has actual knowledge of dust conditions which require abatement pursuant to this subrule. Reasonable precautions may include, but not be limited to, the following procedures.

- 1. Use, where practical, of water or chemicals for control of dusts in the demolition of existing buildings or structures, construction operations, the grading of roads or the clearing of land.
- Application of suitable materials, such as but not limited to asphalt, oil, water or chemicals on unpaved roads, material stockpiles, race tracks and other surfaces which can give rise to airborne dusts.
- 3. Installation and use of containment or control equipment, to enclose or otherwise limit the emissions resulting from the handling and transfer of dusty materials, such as but not limited to grain, fertilizer or limestone.
- Covering, at all times when in motion, openbodied vehicles transporting materials likely to give rise to airborne dusts.
- Prompt removal of earth or other material from paved streets or to which earth or other material has been transported by trucking or earth-moving equipment, erosion by water or other means.
- 6. Reducing the speed of vehicles traveling over onproperty surfaces as necessary to minimize the generation of airborne dusts.

657.1 Nuisance — what constitutes — action to abate — electric utility defense.

1. Whatever is injurious to health, indecent, or unreasonably offensive to the senses, or an obstruction to the free use of property, so as essentially to interfere unreasonably with the comfortable enjoyment of life or property, is a nuisance, and a civil action by ordinary proceedings may be brought to enjoin and abate the nuisance and to recover damages sustained on account of the nuisance. A petition filed under this subsection shall include the legal description of the real property upon which the nuisance is located unless the nuisance is not situated on or confined to a parcel of real property or is portable or capable of being removed from the real property.

2. Notwithstanding subsection 1, in an action to abate a nuisance against an electric utility, an electric utility may assert a defense of comparative fault as set out in section 668.3 if the electric utility demonstrates that in the course of providing electric services to its customers it has complied with engineering and safety standards as adopted by the utilities board, and if the electric utility has secured all permits and approvals, as required by state law and local

ordinances, necessary to perform activities alleged to constitute a nuisance.

Chronic Toxicity

Prolonged and repeated inhalation of respirable crystalline silica-containing dust in excess of appropriate exposure limits has caused silicosis, a lung disease. Not all individuals with silicosis will exhibit symptoms (signs) of the disease. However, silicosis can be progressive, and symptoms can appear at any time, even years

after exposure has ceased. Symptoms of silicosis may include, but are not limited to, the following: shortness of breath; difficulty breathing with or without exertion; coughing; diminished work capacity; diminished chest expansion; reduction of lung volume; right heart enlargement and/or failure. Smoking may increase the risk of developing lung disorders, including emphysema and lung cancer. Persons with silicosis have an increased risk of pulmonary tuberculosis infection.

Respirable dust containing newly broken silica particles has been shown to be more hazardous to animals in laboratory tests than respirable dust containing older silica particles of similar size. Respirable silica particles which had aged for sixty days or more showed less lung injury in animals than equal exposures of respirable dust

containing newly broken particles of silica.

There are reports in the literature suggesting that excessive crystalline silica exposure may be associated with adverse health effects involving the kidney, scleroderma (thickening of the skin caused by swelling and thickening of fibrous tissue) and other autoimmune disorders. However, this evidence has been obtained primarily from case reports involving individuals working in high exposure situations or those who have already developed silicosis; and therefore, this evidence does not conclusively prove a causal relationship between silica or silicosis and these adverse health effects. Several studies of persons with silicosis also indicate an increased risk of developing lung cancer, a risk that increases with the duration of exposure. Some of these studies of silicotics do not account for lung cancer confounders, especially smoking.

Limestone is not listed as a carcinogen by the International Agency for Research on Cancer (IARC), the National Toxicology Program (NTP), or the Occupational Safety and Health Administration (OSHA). In October 1996, an IARC Working Group re-assessing crystalline silica, a component of this product, designated respirable crystalline silica as carcinogenic (Group 1). The NTP's Report on Carcinogens. 9th edition, lists respirable crystalline silica as a "known human carcinogen." In year 2000, the American Conference of Governmental Industrial Hygienists (ACGIH) listed respirable crystalline silica (quartz) as a suspected human carcinogen (A-2). These classifications are based on sufficient evidence of carcinogenicity in certain experimental animals and on selected epidemiological studies of workers exposed to crystalline silica.

Building Department Services Agreement

BUILDING INSPECTION Centerville, Iowa

THIS AGREEMENT, made and entered into this _	day of	, 2024 by and betweer
Centerville Iowa, a municipal corporation, herei	nafter referred t	o as the Municipality , and
VEENSTRA & KIMM, INC., a corporation organize	ed and existing ι	under the laws of the State of
Iowa, hereinafter referred to as the Building Off	icial/Engineer.	

WITNESSETH: THAT WHEREAS, the Municipality has enacted by ordinance the 2018 ICC & Uniform Building Code Series utilizing the standards for construction within the city limits, and

WHEREAS, the Code of Ordinances provides for the appointment of a building official responsible for the enforcement of the building code.

WHEREAS, the municipality's desire to appoint and confirm the appointment of the Engineer as the building inspector for all 3+ unit residential & all commercial and industrial building inspection projects.

NOW, THEREFORE, the parties agree that the retention of the Building Official/Engineer as building inspector shall be subject to the following terms and conditions, to wit:

- 1. SCOPE OF SERVICES. The Engineer agrees to provide those services necessary to comply with the requirements of the building code ordinance. With said services including but not necessarily limited to the following:
 - a. Provide inspection of new construction, remodeling, renovation, and other associated services for 3+ residential, all commercial and industrial structures in accordance with the Code of Ordinances of the municipality.
 - b. Provide the permit forms, schedule inspections, and perform all required inspections.
 - c. Coordinate building code inspection and enforcement with building codes and fire & zoning codes according to Association policy and procedure.
 - d. Follow municipal procedures, and prepare necessary forms for initial inspection, follow-up and final inspection on all assigned projects including issuance of appropriate occupancy permits.
 - e. Perform required plan checks and site plan reviews in accordance with applicable standards as requested by the municipality.

- f. Attend meetings of the City Council, Plan and Zoning Commission and Board of Adjustment when required.
- **3. INDEMNIFICATION AND INSURANCE**. The Building Official/Engineers shall and hereby agrees to hold and save the municipality harmless from any and all claims, settlements and judgments, to include all reasonable investigative fees, attorney's fees, suit and court costs for personal injury, property damage, and/or deaths or damages arising out of the Building Official/Engineers' or any of its agents' and servants' and employees' negligent acts, errors or omissions for services under this Agreement.

The Building Official/Engineers shall provide evidence of comprehensive general liability coverage and contractual liability insurance by an insurance company licensed to do business in the State of Iowa in the limits of at least \$1,000,000 each personal injury accident and/or death; \$1,000,000 each aggregate personal injury and/or death; and \$1,000,000 for each property damage accident. The evidence shall also state that it cannot be canceled or materially altered without giving the City at least thirty (30) days written notice.

The Engineers shall also provide evidence of automobile liability coverage in the limits of at least \$1,000,000 bodily injury and property damage combined. The evidence shall also state that it cannot be canceled or materially altered without giving the City at least thirty (30) days written notice by registered mail.

The Building Official/Engineers shall and hereby agrees to hold and save the municipality harmless from any and all claims, settlements and judgments, to include all reasonable investigative fees, attorney's fees, suit and court costs for all personal injury and death to any and all of the Building Official/Engineers' agents, servants and employees occurring under the Workers Compensation Act of the State of Iowa, and shall provide evidence that such insurance is carried in the statutory limits. The Building Official/Engineers shall also be protected against claims for injury, disease or death of employees which, for any reason, may not fall within the provisions of the Workers Compensation law.

The Building Official/Engineers shall provide evidence of errors and omissions insurance by insurance company licensed to do business in the State of Iowa, in the limit of \$1,000,000 for claims arising out of the professional errors and omissions of the Building Official/Engineers. The evidence shall also state that it cannot be canceled or materially altered without giving the City at least thirty (30) days written notice by registered mail.

- 4. PLAN REVIEW AND CHECKING. In accordance with the provisions of the building codes, a plan review and plan check fee may be required for new commercial, multi-family or tenant improvement projects. The Building Official/Engineer when requested by City shall make a determination for those projects subject to the plan review requirement whether the plan review is required. A 65% plan review fee will be assessed for new commercial, multi-family or tenant improvement projects within 10 working days. In order to provide this, the contractor must provide all of the required submittals with the permit application. A proven process has been established and attached to this document.
 - **5. COMPENSATION.** The City shall compensate the Building Official/Engineers a lump sum amount for each building inspection activity (Invoiced Monthly) based on the following:

Hourly rate charged:

Building Inspector II = \$119.00/hr.

Plus Mileage = Both ways @ 0.67 per mile. (Or current IRS Mileage Rate) Mileage is a onetime per day charge originating at their HOR or another community. Hourly rates applicable during drive time.

Plan Review = V&K retains 100%.

- **6. PAYMENT.** The municipality shall make payment to the Building Official/Engineer fees due for building inspection and plan check within thirty (30) days after the receipt of the fee from the applicant.
- **7. TERMINATION.** This Agreement may be terminated by either party upon thirty (30) days written notice.
- **8. ASSIGNMENT.** This Agreement and each portion thereof shall be binding upon the successors and assigns of the parties hereto.

The undersigned do hereby covenant and state this Agreement is executed in duplicate as though each were an original and that there are no oral agreements that have not been reduced to writing in this instrument.

It is further covenanted and stated there are no other considerations or monies contingent upon or resulting from the execution of this agreement, nor have any of the above been implied by or for any party to this Agreement.
